Hope to see you on the water and at our meetings.

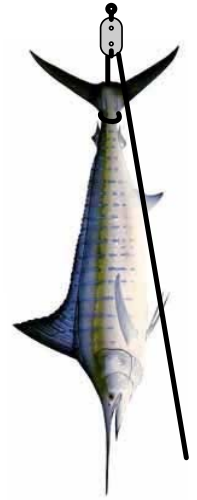
