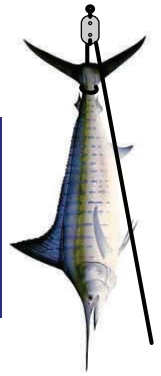
Hope to see you at the meeting before the tournament and great weather.

# **MBMC BAY ONLY POTPOURRI TOURNAMENT ENTRY FORM**

**March 20-21, 2010**

Entry fees are \$15.00 per MBMC member, & \$20.00 per guest. An optional \$5.00 cash jackpot fee will be collected from those who wish to participate. The heaviest single fish of the tournament will collect the optional jackpot. The target species for this tournament is any fish, excluding Rays and Sharks.

Saturday March 20, 2010, fishing starts at 12:01 AM and continues until you can make the weigh in at 6:00 PM at the Dana Landing dock. Fish not weighed in by the 6:00 pm deadline on Saturday may be weighed in Sunday when the scales are open. Fishing continues Sunday March 21, 2010 for this tournament and final weigh-in's are required no later than 6:00 pm at the Dana Landing Dock.

Tournament entry fees & forms will be collected at Dana Landing Market & Fuel Dock. All entries must be submitted by 6:00 pm on March 19,2010 at Dana Landing, or in person at the Captain's Meeting.

In the event of weather conditions and/or any other potential reason to cancel or postpone the tournament, a message will be left on the MBMC message machine at 619-224-8862. The decision will be made by the board no later than 9:00 pm the day before the tournament and put on the message machine as well as posted on the web site. Please check either the message line and/or the web site if conditions look questionable. M.B. Lifeguard current weather conditions and warnings can be heard at 619-221-8824.

## **MBMC 2010 Bay Only Potpourri Tournament Rules**

1. Tournament will be two days, commencing Saturday, March 20, 2010 @ 12:01 AM and ending @ 6:00 PM Sunday March 21, 2010. All participants are eligible to fish either or both days.
2. Tournament entry fees will be collected at Dana Landing Market and Fuel Dock. All entries must be submitted by 6:00 PM, Friday March 19, 2010 at Dana Landing, faxed to the tournament chairman at 858-549-0604 or in person at the Captain's Meeting at Marina Village.
3. **All entries not paid at time of sign-up must be paid in full by 6:00 PM, on Sunday, March 21st** to remain eligible for the tournament.
4. Fishing area is either inside the Mission Bay Aquatic Park extending north from the tip of the south jetty to the tip of the north jetty extending eastward; or inside San Diego bay extending north from the western tip of Zuniga Jetty to the tip of Point Loma and all areas eastward inside the bay. Any boat caught fishing or trolling in transit between Mission Bay and San Diego Bay will be disqualified.
5. I.G.F.A. rules will apply to tackle and method of take.
6. Weigh in time is from 12:00 PM to 6:00 PM Saturday and 12:00PM to 6:00PM Sunday. You must be in the Dana Landing Basin and be visible from the weigh-in dock by 6:00 PM.
7. Top boat shall be decided by the boat with the HEAVIEST WEIGHT of their top 3 fish of the tournament species. All member owned boats, dingys, and kayaks are eligible if listed on entry form. The species targeted in this tournament are all legal species worth **1 point per pound** except sharks and rays. In this Tourney only, Calico and Sand Bass will count as **2 points per pound** and Spotted Bay Bass counts as **3 points per pound**.
8. Radio Communications will be on Channel 69. The club and other boats can be contacted on this channel.
9. Scoring: 4 points for first place angler with heaviest target fish, 3 for second, 2 for third, and one point for a fish weighed in of the targeted species. These points accumulate for all MBMC tournaments open to all members for the angling year 2010. A maximum of 8 of 9 tournaments will determine the total score for each angler and boat. A minimum of 5 tournaments during the year must be fished to be in contention for the top boat or angler.
10. You are responsible for having all the necessary California Fishing Licenses and Mexican Fishing Permits when fishing California and/or Mexican waters. You should also be aware of the laws governing the number and size of fish in your possession.
11. All protests must be received in writing no later than one hour after final weigh-in and will be reviewed by the Protest Committee for validity.
12. Tournament results will be posted soon after final weigh in on Sunday. Awards will be presented at the next social event.
13. Payouts for first, second, and third place will be based on a percentage of the total amount of entry fees collected.
14. **Optional Cash Jackpot:** A voluntary \$5 cash jackpot per person entry is available to enter, however all anglers fishing on the same boat except Junior Anglers must be entered in order to qualify for the winner-take-all largest fish cash jackpot.
